Abstract: Maximum 300-350 words to be sent on or before 5<sup>th</sup> November, 2020

Full Paper: The length of full papers shall be in range of 2500 to 3000 words.

Title: The title will be the first page of the paper and shall contain details of title of paper, Author(s)

Name, Affiliations, Contact details (Email-ID & Phone No.) Second Page of manuscript will be

abstract followed by full paper article.

Referencing Style: APA 6<sup>th</sup> Edition (Refer to the manual for APA Style)

- The abstract & paper must be typed in MS Word and it should be in A4 size paper in Times New Roman & 12 points with spacing 1.5 and margin: 1 inch (2.5 cm) from all sides, Fully justified and pages numbered 1, 2..so on.
- The Research Papers / Articles / Manuscript must be original and should not have been submitted elsewhere. The Authors are advised to submit a Certificate of originality of their work.
- The Researcher must check papers for plagiarism and must ensure that contents without citation and/or reference need not to be submitted.
